Annual Conference 2006

With the idea of promoting professionalism and quality of management practices in the business community in Sri Lanka, the 2nd Annual Conference of the Association was conducted on the topic "Beyond Traditional Boundaries" with a full house of delegates. Six eminent business personnel who withstood civil unrest, ethnicity war and natural calamities to reach their goals with success, shared their vast experience and technical knowhow, apprising participants of their real life situations. This provided an opportunity to the delegates to benefit by listening, studying and emulating innovative management thinking and practices to meet the challenges they face in the global market place.

Seminars for the industry




The event was organized by Chandana Weerasooriya and assisted by Rohan Seneviratne.

Annual Charitable Event - Renovation of Dormitory at "Sucharithodaya"

The charitable event for the year 2005/06 was successfully carried out at the "Sucharithodaya Samaja Seva Sangamaya" Children's Home at Pamunuwa, Maharagama. The boys' dormitory and another building were repainted and ceiling fans installed fulfilling a pressing need at this haven for children from broken families or without parents, and channeled by the courts. The Sangamaya led by its Chairman, Mr. Muthubanda does an excellent job of looking after the inmates and workers numbering some 180 persons, raising its own funds when the grants from the Provincial Councils are found wanting. The opening ceremony was held on the evening of Saturday, the 8th April with the Executive Committee of the CMBAAA present. Short eats from FAB Foods and a drink of milk were served to all the children, the older inmates and workers. Some members of the Association contributed their mite to provide, exercise books, children's text books and sponsoring some of the refreshments served. It was a joy to see the children who are well trained and disciplined, looking pleased in their newly renovated accommodation. One of the children from the home proposed a vote of thanks at the end of the ceremony. This event was organized by Neil Perera assisted by Suresh Kumar & Chandana Weerasooriya.

Annual Management Conference 2006



On 1st March 2006, the Colombo MBA Alumni Association held its 2nd Annual Conference on the theme "Beyond Traditional Boundaries-2006" at Ceylon Continental Hotel, Colombo. The objective of this conference was to create an environment and business culture in which unfettered thinking would be possible. Often, businesses are restrained by traditional and conventional thinking which restricts their development. In Sri Lanka, despite the imperfect business environment over the last couple of decades, there are many examples of individuals and corporations who have braved the odds and with bold, innovative thinking entered hitherto untapped markets with unprecedented, almost unimaginable success. CMBAAA set out to create a forum for sharing "out of the box" thinking, where delegates could be inspired by the success stories of the entrepreneurs and business leaders who made presentations. Delegates were also afforded the opportunity of a brief person to person dialogue with the speaker at the end of each session. Over 125 delegates from diverse sectors of economic activity participated. Some of Sri Lanka's leading entrepreneurs and business leaders who were not constrained by "traditional boundaries" addressed this conference, sharing their real life experiences with the participants. The speakers who addressed the conference were Mr. Ajith Nivard Cabraal - Senior Economic Advisor to H.E. the President of Sri Lanka, Mr. Ravi Fernando – Director, Corporate Branding & CSR, MAS Holdings Ltd, Deshamanya A.Y.S. Gnanam – Chairman, St Anthony's Group, Mr. Keith Modder – Managing Director, Asian Operations, Virtusa Ltd, Mr Moksevi Prelis – Chairman, SME Bank and Mr. Lalith Kahatapitiya - Chairman / Managing Director of KIK Group. Wide publicity was given to this Annual Conference through national newspapers and brochures and with these CMBAAA succeeded in increasing the public awareness about the association and its activities. This management conference was of very high standards and the delegates who participated highly commended the programme and the professional manner in which the event was organized by the CMBAAA. Our President Prasad Jayasuriya led the team in organizing this conference and he was

given the fullest support by all Exco's with extra special contributions coming from Mano Navaratnarajah & Chris Corea.

Members' Day 2006

They still live in a temporary house at the "Kithulewela Refugee Camp", Matara. These two boys are brothers studying at St. Servatius' College, Matara and they lost their father and two other members of the family from tsunami and survived with their mother.

The CMBAAA continued to review their school progress reports at the end of the each school term to ensure that the children and their mother are aware that these scholarships are to inspire them to continue their edu cation and become useful citizens of the country. These funds are handled through the special account, "Colombo MBA Alumni Association – Tsunami Relief Fund : Account # 0050372324" at Hatton National Bank, Main Branch opened exclusively with the view of looking after the long term educational needs of these children affected by Tsunami.

Working with the University to improve the quality of the MBA programme During the year, CMBAAA worked very closely with the Faculty of Management & Finance of the University of Colombo to ensure that the standard of the MBA prgramme is improved. We had a very good relationship with the Dean and the faculty members and University Liason Committee was always there to identify the support the faculty needed from the association. We continuously gave our suggestions to the faculty based on the feedback we get from the MBA students and the industry regarding the MBA program and these suggestions were received very positively by the University authorities. This year too Executive Committee members represented the CMBAAA in the interview panels that evaluated the candidates in June 2006 for the intake of the new MBA batch.

Seminars organized for the private sector companies

On the requests made by the corporate sector, CMBAAA successfully organized two workshops conducted by Mr Dhammika Kalapuge on "Customer Service Excellence". These were held on 15th September 2005 & 30th September 2005 at Ceylon Continental Hotel for the staff members of Keels Business Systems Ltd, John Keels Office Automation (Pvt) Ltd and John Keels Computer Services (Pvt) Ltd and the participants were extremely satisfied with the programs. Prasad Jayasuriya and Suresh Kumar organized and coordinated the programmes on behalf of the CMBAAA.
