





the end of an year, especially when it has been an eventful and satisfying one that he can always look back at.

At the outset, we had an overflow of interest in new members wishing to join the Executive Committee, an indication of the value created by the Association over the years. There was no lack of new project ideas or ventures to take on, including a goodwill visit to the University of Jaffna to give an impetus to undergraduates to broaden their horizons, the beginning of a North-South dialogue of sorts.

With hindsight, I see that, for an Association managed by volunteer members, we were a little overambitious when planning our annual business calendar which, for instance, resulted in two major events happening on consecutive days. However, thanks to the commitment of the members, we did manage to complete all but two events in a lengthy list planned in keeping with our theme "Association for greater heights". Yet, my role was that of a facilitator where all the hard work was done by the Committee Chairpersons and EXCO members who should get all credit as well. If

anything was amiss, the responsibility and blame should be directed at my door step!

A unique point this year that is worth noting is that we were able to have a positive net income from all Events, not just from those known as 'fund raisers'. This has brought a surplus in the year which is roughly equal to the total Accumulated Fund as at 31/3/2010, which has prompted plans for establishing a Trust that will ensure continuity and due accountability in the future.

The Committee Chairpersons were exceptional in handling the Events they undertook. They were Nishantha Jayasooriya, Tharuka de Silva, Jude Silva, Upali Ratnayake, Rohana Ellawala, Sarmaa Mahalingam and Pubudu de Zoysa who chaired three projects. And there were the ever faithful Past Presidents serving the Executive Committee such as Chris Corea, Neil de Mel, Prasad Jayasuriya, Hilary Fernando and Anusha Wijegunaratne who shouldered

substantial responsibilities. In addition, I could not have done without the guidance and support of other Presidents of the past namely Neil Perera, Pushpakumara and Rohan Senevirathne who helped keep true to the culture and values of the Association.

The year had an abundance of event sponsors who are usually a hard to find commodity. Commencement of the 14th year of Operation

The 13th Annual General Meeting of the MBA Alumni Association of the University of Colombo which marked the completion of 13 years of operation was held on 16th July 2010 at the Earl's Court, Cinnamon Lakeside. At the AGM held on 16th July 2010, a new Executive Committee was unanimously elected with Mr. Jude Fernando as the new President and the out-going President Mr. Anusha Wijegunaratne handed over the reins of the Association to Mr. Jude Fernando, after steering it through another successful year marked by various programs and activities

including the Speech Craf Program introduced as a unique new project during his tenure.

The Executive Committee for the year under review reflects the growing strength and popularity of the Association in that it has got expanded to accommodate new "Colombo MBAs" willing to join as Ex-Co Members. Currently, the Executive Committee consists of 25 Members including several new faces.

Planning the Year

Keeping to the tradition followed year after year, the new Executive Committee had a brainstorming session at the Palm Village Hotel USK in order to develop and finalise the plans and strategies for the year 2010/11. Almost all Ex-Co Members attended this special two-day meeting of the Committee held on 24th and 25th July 2010 and at the end of these deliberations, the major programs and activities to be carried out during the year were decided on and Sub-Committees were appointed to take responsibility for the implementation of the envisaged programs. Whilst continuing with the major regular events in the Calendar of the Association such as the Budget Seminar, the Management Conference and the MBA Nite etc. it was decided to add some new programs in order to enhance the image and the stature of the Association, The proposal to under-take a special Goodwill Visit to the Jaffna University in the context of the efforts being made at all levels to strengthen the ties between the North and the South was one such new program.

In order to place the Association on a sound footing, it was also decided to pursue membership development in a more aggressive and systematic manner with delivery of enhanced value to the Members. Another decision taken was to strengthen the finances of the Association through more sponsorships and better marketing of the major events in order to provide it with the capacity to operate more dynamically in achieving its objectives.

Realizing the need to make a formal review of the progress made in the first few months and to carry out a critical reassessment of the strategies adopted, the President took the initiative to have a Mid-Year Brainstorming Session. Accordingly, the 2nd Brainstorming Session for the year was held at the Pearl Banquet Hall, Ceylon Continental Hotel on 8th January 2011 with the participation of almost the entire Executive Committee. At the end of this special half-day session, a pool of new ideas was created for implementation in the rest of the year/ in the future and the overall strategy was also refined and re-shaped with greater focus on membership development and delivery of a better deal to the General Membership.

Working the Plans

A number of Sub-Committees were appointed to take responsibility for the implementation of the various Projects and Programs identified and agreed on at the Brainstorming Session held on 24th and 25th July 2010 and these Sub- Committees met several times in the weeks/months preceding the respective Events in order to draw up the execution plans, discuss the numerous issues and finalize the arrangements for the successful conduct of each Program. In addition, the Executive Committee had regular monthly Meetings in order to review the progress made in respect of each envisaged Project/Program and to discuss and sort out other matters. The monthly Treasury Reports were also submitted and discussed at these Monthly Meetings.

Altogether 12 Monthly Executive Committee Meetings were held during the year. Most of these Meetings were held in the Board Room of the Faculty of Graduate Studies of the University of Colombo and some of the Sub- Committee Meetings were held at the Premises of the Faculty of Management and Finance. The Association wishes to express its deep gratitude to the Vice- Chancellor Prof Kshanika Hirimburegama, the Dean of the Faculty Dr. P.S.M. Gunaratne and the Unit Coordinator Post- Graduate and Mid- Career Program Mr. J.A.S.K. Jayakody for allowing / for securing the approval for the Executive Committee to conduct these meetings within the Premises of the University and for the staff support provided to facilitate the monthly EX-CO Meetings. It is indeed a great gesture of goodwill and co-operation for the University Authorities to have allowed the Association access to these facilities including the FGS Board Room meant for the exclusive use of the University.


Budget Seminar

Message from the Treasurer

I am proud to be the Treasurer of the MBA Alumni Association of the University of Colombo and having the opportunity of presenting the Treasurer's Report for the financial year ended 31st March 2011 on behalf of the Executive Committee of the Association. The Audited Financial Statements comprising the Balance Sheet and the Income and Expenditure Statement together with relevant notes have been included for your reference and information.

This year, the Association was committed to expand the activities to a large extent so as to build the Accumulated Fund and to strengthen its financial position. The main activities organized by the Association during the year have been highlighted in the Operations Review. The Association has recorded the highest net income over expenditure before tax of Rs. 1,821,167/- for the year ended 31st March 2011. The Association has provided for taxation of Rs. 365,351/- as payable for the year of assessment 2010/11. The Association has enhanced the fixed investments by Rs. 125.642/- through interest earnings and the Executive Committee has decided subsequently to transfer Rs 1.25 Mn from current account to Fixed Deposit to increase the investment to Rs. 3,298,017.47. The Membership Committee played a major role in expanding the life membership base of the Association during the year adding 37 new members as at 31.03.2011.

The Association was able to achieve one of its major expectations of strengthening its financial base under the committed leadership of the President and the very active Executive Committee. The Association was able to successfully conclude two major activities which contributed considerably to the net income for the year. One of the main activities successfully completed was the Budget Seminar which took the Association to the next level enhancing its image and financial position and earning a net income of Rs. 724,374/- while the other major contributor was the Annual Management Conference which also played a major role to enhance the Association's image as well as net income by Rs. 802,813/-.

The Association successfully completed the 9 activities planned during the year. The MBA Walk completed on 7th May 2011 ended up with net income of Rs. 245,485/- to the Accumulated Fund.

I would like to thank all members and institutions that helped the Association during the past year in various ways. Special thanks to the Management Faculty of the University of Colombo for its invaluable support and encouragement, to Event Sponsors and to our Media Sponsor, Wijeya Newspapers (Pvt) Ltd for their significant contribution.

1. General Policies

1.1 Basis of Preparation

These Financial Statements are Presented in Sri Lanka Rupees and have been Prepared on the historical cost basis.

These Financial statements are prepared on the assumption that the association is a going concern, i.e. as continuing in operation for the future. It is therefore assumed that the association has neither the intention nor the necessity of liquidation or of curtailing materially the scale of its operations.

1.2 Post Balance Sheet Events

All material events occurring after the balance sheet date are considered and where necessary, adjustment made in these financial Statements.

1.3 Taxation

As per the section 101 of the inland revenue Act 2006, the association is liable to pay tax at 20%. The provision for income tax is made in the financial statements accordingly.

Valuation of Assets.

2.1 Receivables

Receivables are stated at the amounts they are estimated to realize inclusive of provision for bad and doubtful debts.

2.2 Property, Plant and Equipment

2.2.1 Cost Valuation

Property, Plant and Equipment are recorded at cost (or valuation) less accumulated depreciation, which is provided for on the bases specified in 2.2.2 below. The cost of property, plant and equipment is the cost of purchase or construction together with any incidental expenses thereon.

Expenditure incurred for the purpose of acquiring, extending or improving assets of a permanent nature by means of which to carry on the business or to increase the earning capacity of the business has been treated as capital expenditure.

2.2.2 Description

The provision for depreciation is calculated on the cost or valuation of all property, plant and equipment other than freehold land, in order to write off such amounts over the estimated useful lives by equal installments as follows:


