

### Dismantling the Budget

One of the most successful events of Second Quarter of 2010/11 was the Budget Seminar held on 23rd Nov 2010 at Ceylon Continental Hotel. Although the Budget Seminar is a regular event in the Calendar of the Association, this year's Seminar generated much higher interest among all target segments of participants due to the expectation that the 2011 Budget would be a groundbreaking one with far-reaching pro-development proposals. The Seminar was jointly organized by the Association and the Daily Financial Times of the Wijeya Newpapers Ltd and the intensive publicity given to the Event by the Daily FT contributed in no small measure to its ultimate grand success with the hard-to-breakrecord of 430 participants including several company CEOs. The Keynote Speaker was Dr.P.B.Jayasundara Secretary, Ministry of Finance. Other Speakers were Professor Sirimal Abeyratne of the University of Colombo, Mr. Ashroff Omar ,CEO Brandix Lanka Ltd, Mr. N.R. Gajendran

Professor Sirimal Abeyratne, whilst commending the Budget for the pro-development measures highlighted the danger of excessively relying on inward remittances and the need to address the current situation of slow inflow of Foreign Direct Investment

The Budget Seminar was organized by a sub-committee headed by the Vice President Mrs. Pubudu P.De. Zoysa with the active support of the Ex-Co Members Messrs Saranga Wijeratne, Neil De Mel and





Lalith Sumanasiri and others. The Editor of Daily Financial Times Mr. Nisthar Cassim also made a significant contribution to the success of the Seminar.

Members of the Association visited the Seguvantivu and Vidathamunai Wind Power Projects located at Puttalam, on 16th Oct 2010. The choice of this Project for the Trip was in keeping with the tradition making the Association's Annual Family Outing an opportunity for members to learn about and update themselves with new things happening around the country. The Group consisted of about 50 participants including members and their families and for those who were able to take part in this Trip, it was a wonderful opportunity to enjoy a day-out in a serene atmosphere away from home and to see a



pioneering unique power project supplying renewable "green energy" to the country. It was quite interesting to see how the Project has transformed a barren sandy stretch of land into a productive economic asset and tourist attraction of sorts. This Field Trip was organized by a sub committee headed by the Secretary Mr. N. Jayasooriya, with the assistance of other members.




# **Evening Lecture**

The first Evening Lecture for 2010/11 was held on 28th October 2010 at The Hotel Cinnamon Lakeside. The Guest Speaker was Mr. YOSHIAKI KATO.

Managing Director, Toyota Lanka (Pvt) Ltd. The Lecture was well - attended with about 101 Registrations and the participants included company CEOs and other senior corporate executives. Mr. Kato spoke on the subject "Managing the Toyota Way" and explained how the Toyota Motor Corporation and its Subsidiaries use the

people- centred approach as the cardinal principle in managing their affairs and highlighted the importance given by them to special staff training focused on corporate values of the Group. He also emphasized the importance of lean management and reduction of waste and explained how these objectives are achieved across the Toyota Group by translating these ideas into well-accepted management concepts and practices. Another enlightening revelation made by him is

that performance in the Toyota Group is measured mainly by the return on risk- assets such as stocks and inventories which is worthy of emulation by Sri Lankan Companies as a way of improving their working capital management.

### MBA Nite 2010


